RESOLUTION NO. SP- 5644, S-2012

A RESOLUTION AUTHORIZING THE OFFICE OF COUNCILOR ALLAN BENEDICT S. REYES, CITY COUNCILOR, 3RD DISTRICT, QUEZON CITY TO PURCHASE TWO (2) UNITS OF PASSENGER VAN AMOUNTING TO TWO MILLION EIGHTY SEVEN THOUSAND EIGHT HUNDRED THIRTEEN PESOS (PHP2,087,813.00) INTENDED FOR THE MONITORING OF PROGRAMS ANG PROJECTS OF THE SAID OFFICE TO BE CHARGED TO THE OFFICE OF THE CITY COUNCILORS FUND, QUEZON CITY.

WHEREAS, the Office of Honorable Allan Benedict S. Reyes has requested the purchase of two (2) passenger vans duly approved by Honorable Ma. Josefina G. Belmonte, City Vice Mayor with the approved Obligation Request and Advice of Allotment No. 11-02021 for multi-purpose vehicles to be used by the Office of Councilor Reyes in his official duties and functions;

WHEREAS, that the said passenger vans have the following specifications;

1. 2011 passenger van – 4JA1-L4-cylinder direct injection diesel engine, EURO 2. Displacement: (CC) 2499, PS/rpm: 81/3900, Nm/rpm: 177/2000, Overall LxWxH: 5140x1710x1950. Dial type full mode control aircondition, extended aircon duct. System, Variant 1 with rear aircondition, Semi elliptical leaf spring with telescopic shock absorber-Halogen multi-reflector type head lamp, side market lamp, two 3-point+1 center lap front seat belt, dual bench type, split folding rear seats, Kenwood KDC MP3029 Tuner/CD/MP3 capable. Load up to 15 passengers in utmost safety and comfort with LTO registration and markings as Councilor's design. Unit cost: Php897, 813.00.
2. 2011 passenger van – 4JB1-TC 4 cylinder, watercooled, 4 cycle inline, OHV with automatic Engine Stop device, turbo charged with intercooler, direct injection diesel. Displacement: 2.8L, PS/rpm:67(91)/3400, N-m(kg-m)/rpm:196(20.0)/2000 GVW:3800kgs. Payload: 2,325kgs, 75 liters full tank capacity. Transmission: 5 speed overdrive, synchromesh on all forward gears shot level and remote control. Tires: 7.00-15-12PR, 5 including spare tires, 6 stud wheels, brake, drum type, hydraulic dual circuit with vacuum assist, front two leading, rear dual leading. Steering: recirculating ball and nut with power assist, tilting. Suspension: semi-elliptical alloy steel leaf spring, and hydraulic double telescopic shock absorber at front and rear. Cab type: tilt cabin and monocoque construction, single-in-dash CD tuner with 2 speakers, panoramic, non-slip aluminium and steel steps with LTO registration. Unit cost: Php 1,190,000.00.

WHEREAS, the Office of Councilor Reyes has already endorsed the Purchase Request of the said passenger vans to the Office of the late Secretary Jesse M. Robredo of Department of the Interior and Local Government and to the Office of the City Mayor Herbert M. Bautista dated May 31, 2012 and July 17, 2012, respectively;


WHEREAS, pursuant to Administrative Order No. 15, amending Administrative Order No. 233, Series of 2008, the Honorable City Mayor Herbert M. Bautista has already sought permission and authorization from the DILG in his letter dated September 5, 2012, addressed to Hon. Paquito N. Ochoa Jr., Officer-In-Charge, DILG for the acquisition of the above-described passenger vans amounting to Php 2,087,813.00, which amount is included in the 2012 Annual Budget of the City Government under the Quezon City Council.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Office of Councilor Allan Benedict S. Reyes, City Councilor, 3rd District, Quezon City to purchase two (2) units of passenger van amounting to Two Million Eighty Seven Thousand Eight Hundred Thirteen Pesos (Php 2,087,813.00) intended for the monitoring of programs and projects of the said office to be charged to the Office of the City Councilors fund, Quezon City.
