(KAPAMALQ, Q.C., INC.),* in the amount of One Million Pesos (P1,000,000.00) to be taken from the appropriation for grants, subsidies, and contributions under the 2012 Annual Budget of the Office of the Ciiy Mayor or from any available funds of the City Treasury.
