A RESOLUTION URGING THE HONORABLE CITY MAYOR HERBERT M. BAUTISTA TO EXTEND FINANCIAL ASSISTANCE IN BEHALF OF THE QUEZON CITY GOVERNMENT TO THE VICTIMS OF TYPHOON "PABLO" (BOPHA) AT SURIGAO DEL SUR, COMPOSTELA VALLEY, DAVAO ORIENTAL AND TO SUPPORT THE RELIEF OPERATIONS OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FOR PROVINCES, CITIES AND MUNICIPALITIES AFFECTED DURING ITS ONSLAUGHT LAST DECEMBER 4, 2012.

WHEREAS, in the morning of 4 December 2012 (Tuesday) Typhoon "Pablo" (International Codename: Bopha) ravaged provinces of Central Visayas and Mindanao;

WHEREAS, the National Disaster Risk Reduction and Management Council (NDRRMC) disclosed that, as of 7 December 2012, a total of Four Hundred Eighteen (418) people have been confirmed dead and a total of 306,451 individuals, majority of them in Northern Mindanao are staying in 569 evacuation centers while 4,169 displaced individuals are staying outside evacuation centers;

WHEREAS, as of 6 December 2012, the NDRRMC recorded twelve (12) emergency incidents, five (5) of which were maritime, three (3) flooding one (1) trash slide, one (1) whirlwind, one (1) stranded shipping and one (1) tornado incident;

WHEREAS, a total of twenty six 26 municipalities and four (4) provinces in Regions IV-B, VII, X, XI and CARAGA have been declared under the State of Calamity;

WHEREAS, Rule 18, Section 1 of the Implementing Rules and Regulations of Republic Act No. 10121 (The Philippine Disaster Risk Reduction and Management Act of 2010) provides that upon the recommendation of the LDRRMC and approval of the Sangguniang concerned the LDRRMC may transfer funds to support the disaster risk reduction effort of the LDRRMCs which are declared under a state of calamity;

WHEREAS, the Quezon City Council adopted Resolution No. SP-5361, S-2011 providing similar assistance to other local government units who were devastated by typhoon "Sendong".

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the Honorable City Mayor Herbert M. Bautista to extend financial assistance in behalf of the Quezon City Government to the local government units ravaged by Typhoon "Pablo" (International Codename: Bopha) and to support the relief operations of the Department of Social Welfare and Development for provinces, cities and municipalities affected during its onslaught last December 4, 2012.
