RESOLUTION NO. SP- 5664, S-2012

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO SIGN FOR AND IN BEHALF OF THE QUEZON CITY GOVERNMENT THE TRANSPORT SERVICE AGREEMENT WITH L.E.G. HAULING SERVICES CORPORATION IN THE AMOUNT OF FOURTEEN MILLION NINE HUNDRED TWENTY ONE THOUSAND SEVEN HUNDRED TWO PESOS AND FORTY CENTAVOS (PHP14,921,702.40).

WHEREAS, in response to the growing need for transport equipment to move or transfer materials, paraphernalia, equipment, personnel and the like necessary to further discharge with efficiency basic services of the Quezon City Government, the Bids and Awards Committee on Goods conducted on 22 October 2012 a public competitive bidding for the procurement of systematic deployment of transport equipment services (the "Project") with the total approved budget for the contract in the amount of Php15,000,000.00 in accordance with Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act" and its Implementing Rules and Regulations;

WHEREAS, upon compliance with and in observance of the prescribed requirements under the Government Procurement Reform Act and its Implementing Rules and Regulations, the Project was awarded to L.E.G. Hauling Services Corporation.


