A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO UNIOIL PETROLEUM PHILIPPINES, INCORPORATED FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE FILLING STATION TO BE LOCATED AT KALAYAAN AVENUE CORNER MALINGAP STREET, TEACHERS VILLAGE WEST, QUEZON CITY.
