RESOLUTION NO. SP- 5689, S-2013

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO EXTEND FINANCIAL ASSISTANCE IN THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) TO UP BLISS COMMUNITY ASSOCIATION, INC. FOR THE REHABILITATION/REPAIR OF THE ROOFING SYSTEM OF BUILDING 21 UP BLISS, BARANGAY SAN VICENTE, DILIMAN, QUEZON CITY WHICH WAS RAZED BY FIRE LAST MAY 2012, TO BE TAKEN FROM THE FUNDS OF THE OFFICE OF THE MAYOR.

WHEREAS, a fire occurred at UP Bliss, Barangay San Vicente last May 2012 affecting the residents and partially damaging Building 21;

WHEREAS, UP Bliss Community Association, Inc is requesting the Quezon City Government, through the Honorable Mayor, for financial support to defray the cost of the repair of the roofing system of the building affected by the fire;

WHEREAS, the Department of Engineering estimated the cost of repair of the roofing system of the building and it would appear that the amount needed is One Million Pesos (P1,000,000.00);

WHEREAS, the Honorable Mayor approved the financial assistance as a response to the request of UP Bliss Community Association, Inc for the rehabilitation/re-roofing of the building to ease the burden of the families residing at the said building and the potential hazard not only to the people residing in the said building but to the adjoining structures and its residents as well;


WHEREAS, the City Council affirms the approval of the said financial assistance of the Honorable Mayor to the UP Bliss Community Association, Inc for the rehabilitation of the Roofing System of Building 21 for the safety and convenience of the people residing in the area and its adjacent structures.
