RESOLUTION NO. SP- 5696, S-2013,

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT TO USE THE PORTION OF LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND OR ANY AVAILABLE FUNDS OF THE CITY GOVERNMENT IN THE AMOUNT OF NINETEEN MILLION SIX HUNDRED FIVE THOUSAND SIX HUNDRED FOURTEEN PESOS (P19,605,614.00) TO FULLY IMPLEMENT CITY ORDINANCE NO. SP-2109, S-2011, OTHERWISE KNOWN AS THE "COMPREHENSIVE SIGNS AND SIGNBOARD ORDINANCE OF 2011".

WHEREAS, Section 21 of Republic Act No. 10121, otherwise known as the "Philippine Disaster Risk Reduction and Management Act of 2010", states that, xxx xxx xxx not less than five percent (5%) of the estimated revenue from regular sources shall be set aside as the Local Disaster Risk Reduction and Management Fund (LDRRMF) to support disaster risk management activities such as, but not limited to, pre-disaster preparedness programs xxx xxx xxx;

WHEREAS, in accordance with the provisions of City Ordinance No. SP-2109, S-2011, otherwise known as the "COMPREHENSIVE SIGNS AND SIGNBOARD ORDINANCE OF 2011", which was approved on 12 January 2012, and its Implementing Rules and Regulations (IRR) and the declared policy of the Quezon City government, there is a need to establish a uniform requirements for the design, construction, installation and maintenance of all kinds of signs, signage, billboards and signboards, to address the prevailing proliferation of all illegal signs, signage, billboards and signboards proliferating within the territorial jurisdiction of Quezon City;

WHEREAS, Section 13 of the aforementioned ordinance states that an amount was appropriated for the purchase of equipment for the capability of implementing the said ordinance which shall be taken from the Disaster Risk Reduction Management Fund or any available funds of the city government ";

WHEREAS, the City Government has no capability to fully implement the said ordinance without authorizing the use of the portion of the Local Disaster Risk Reduction and Management Fund which was appropriated thereto;

WHEREAS, pursuant with the provision of the aforementioned Ordinance and its IRR, an Abatement and Demolition provision of Non-conforming Advertising Signs, Signboards, and Billboards has been provided;

WHEREAS, in compliance with the said provisions, the Department of Public Order and Safety (DPOS) has recommended the Budgetary Cost Estimate of the personnel's salaries, vehicles, equipment, tools and other materials that are necessary for the use of the DPOS Demolition/Dismantling Team;


WHEREAS, the amount of Nineteen Million Six Hundred Five Thousand Six Hundred Fourteen Pesos (P19,605,614.00) was the recommended Budgetary Cost Estimate necessary to fully implement the provisions of City Ordinance No. SP-2109, S-2011.
