A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO UNIOIL PETROLEUM PHILIPPINES INCORPORATED FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE FILLING STATION TO BE LOCATED AT LOTS 25 AND 27, BLOCK 2, COMMONWEALTH AVENUE, FAIRVIEW, QUEZON CITY.
