RESOLUTION NO. SP. 5704 S-2013

A RESOLUTION AUTHORIZING THE PURCHASE OF THREE (3) UNITS OF MOTOR VEHICLE BY THE QUEZON CITY GOVERNMENT, THROUGH THE HONORABLE MAYOR HERBERT M. BAUTISTA, IN THE AMOUNT OF THREE MILLION FOUR HUNDRED EIGHTY THOUSAND SIX HUNDRED PESOS (P3,480,600.00) TO BE TAKEN FROM THE FUNDS OF THE OFFICE OF THE CITY MAYOR INTENDED FOR MONITORING OF VARIOUS PROGRAMS AND PROJECTS OF THE QUEZON CITY GOVERNMENT.

WHEREAS, Section 455 (b) (l) (vi) of Republic Act No. 7160 provides that the City Mayor shall represent the City in all its transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panhingsod pursuant to law or ordinance;

WHEREAS, the City Treasurer's Office, Office of the City Administrator and the Business Permits and Licensing Office requested the purchase of three (3) units of motor vehicle amounting to One Million One Hundred Sixty Thousand Two Hundred Pesos (P1,160,200.00) each with the total amount of Three Million Four Hundred Eighty Thousand Six Hundred Pesos (P3,480,600.00);

WHEREAS, specifications of the motor vehicles are as follows:

• Color: Thermalyte (Silver);

4-Speed Automatic Gale-Type and 5-Speed Manual

Transmission, Rack and pinion with power;

• Steering this vehicle with overall curb weight of 1,580 kg. (A/T) supported by a 205/65 R15 6JJx15 Alloy with Center Cup/ with a maximum output of 136PS/5,600 rpm and a maximum torque of 182Nm/4,000 rpm;

New audio system with WMA Compatibility and Auxiliary

Input;

 Dual Front SRS Airbags, seatbelts with DR and Front Passenger Seatbelt warning;

- Child Lock Protector, Side Color Impact Beams and ABS
- With Tint, Matting, Seat Cover, 10 Liters of Fuel;

Bautista has already sought permission and authorization from the Department of the Interior and Local Government for the purchase of the abovementioned motor vehicles amounting to Three Million Four Hundred Eighty Thousand Six Hundred Pesos (P3,480,600.00) which is included in the 2012 Annual General Budget of the Quezon City Government under the Office of the City Mayor..
