A RESOLUTION APPROVING THE QUEZON CITY GENERAL HOSPITAL PRIORITY EXPENDITURES PROGRAM AND AUTHORIZING THE QUEZON CITY GENERAL HOSPITAL TO USE TWO HUNDRED FORTY NINE MILLION FOUR HUNDRED SIXTY ONE THOUSAND SIX HUNDRED PESOS (P249,461,600.00) OF THE HOSPITAL DEVELOPMENT FUND (HDF) FOR THE PROGRAM SUBJECT TO GOVERNMENT AUDITING AND ACCOUNTING LAWS, RULES AND REGULATIONS.

WHEREAS, the QCGH has a proposed Priority Program for the development of the hospital facilities to further improve the delivery of health services to the residents of Quezon City.

NOW, THEREFORE


