RESOLUTION NO. SP- 5725, S-2013

**A RESOLUTION AUTHORIZING THE BARANGAY COUNCIL OF BARANGAY PINAGKAISAHAN TO CONSTRUCT AN ADDITIONAL SECOND FLOOR TO THEIR EXISTING BARANGAY HALL LOCATED ALONG ERMIN GARCIA STREET BESIDE RAMON MAGSAYSAY CUBAO HIGH SCHOOL, BARANGAY PINAGKAISAHAN, QUEZON CITY.**

*WHEREAS, the Barangay Council of Barangay Pinagkaisahan, through their Resolution No. 161, S-2012, is seeking the authority of the City Government to allow them to construct additional second floor on their existing Barangay Hall;*

*WHEREAS, the improvement of Barangay Hall of Barangay Pinagkaisahan had been already granted, through the funding from the Department of Public Works and Highway;*

*WHEREAS, Dr. Romulo B. Rocena, Principal of Ramon Magsaysay Cubao High School, interposes no objection to the proposed improvement and expansion of the existing Barangay Hall which is located along their school sidewalk;*

*WHEREAS, the Barangay Council of Barangay Pinagkaisahan sees and feels the necessity for the expansion of second floor due to the increasing services provided by the barangay and the inevitable increase of their population;*


*WHEREAS, R.A. No. 7160, also known as the Local Government Code of 1991, provides that the function of the Barangay is to "submit to the Sangguniang Panlungsod or Sangguniang Bayan such suggestions or recommendations as it may see fit for the improvement of barangay or for the welfare of the inhabitants thereof";*

NOW, THEREFORE,


