WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its transaction and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to donate, as it does hereby donate, One (1) unit of brand new Jenbei Auto customized body to the City Pound under the Veterinary Services Division of the Quezon City Health Department to be used for the projects and programs of said office and authorizing the transfer of ownership of the said vehicle to the recipient without cost
