WHEREAS, Quezon City Council Resolution No. 8360, S-71, advocates the sale of vehicle and equipment to government officials, officers and employees should they be willing to purchase the same at the appraised value, provided the tax payable due to the government shall be shouldered by the purchaser;

WHEREAS, the sale of the abovementioned vehicle is advantageous for the City Government considering its costly maintenance and surpassed depreciation expense and book value.
