RESOLUTION NO. SP- 5753, S-2013

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO SELL TO MR. ADRIANO I. APOSTOL A CITY GOVERNMENT VEHICLE, DESCRIBED AS 2004 TOYOTA REVO WITH PLATE NO. SHB-189, OFFICIALLY ASSIGNED TO HIM AS ASSISTANT CITY CIVIL REGISTRAR, THE PRICE OF WHICH IS TO BE DETERMINED BY THE CITY APPRAISAL COMMITTEE AND SUBJECT TO EXISTING AUDITING LAWS, RULES AND REGULATIONS.

WHEREAS, on October 20, 2013, Mr. Adriano I. Apostol will retire from government service reaching the mandatory retirement age of 65 years old;

WHEREAS, upon his retirement Mr. Apostol will have rendered 45 years of government service particularly with the Quezon City Government as Administrator of Amoranto Sports Complex and Assistant City Civil Registrar;

Apostol a city government vehicle described as 2004 Toyota Revo with Plate No. SHB-189, officially assigned to him as Assistant City Civil Registrar, the price of which is to be determined by the City Appraisal Committee and subject to existing auditing laws, rules and regulations.
