A RESOLUTION APPROVING THE REVISED INTERNAL RULES OF THE QUEZON CITY COUNCIL, AMENDING RESOLUTION NO. SP 982, S-98, AS AMENDED FOR THE PURI OSE THEREOF.

Introduced by Councilors JESUS MANUEL C. SUNTAY, EUFEMIO C. LAGUMBAY, GODOFREDO T. LIBAN II., RICARDO T. BELMONTE JR., JOSEPH P. JUICO, ALEXIS R. HERRERA, PRECIOUS HIPOLITO CASTELO, JOSE MARIO DON S. DE LEON. JESSICA CASTELO DAZA and RANULFO Z. LUDOVICA.

WHEREAS, the existing Rules of the Quezon City Council were originally formulated in 1970 and since then have undergone mamerous amendments;

WHEREAS, the Quezon City Council has an existing Internal Rules of Procedure adopted by virtue of Resolution No. SP-982, Series of 1998;

WHEREAS, there is a need to update the existing rules in order to be responsive to the changes brought about by progress;

WHEREAS, Republic Act No. 10170, reapportioned the 2nd Legislative District of Quezon City thereby creating two (2) additional legislative districts and twelve (12) Sangguniang Panlungsod seats from such reapportionment;

WHEREAS, there is a need to amend the Rules of the Quezon City Council to accommodate the additional twelve (12) members of the City Council from the two (2) newly created legislative districts.
