RESOLUTION NO. SP- 5764, S-2013

A RESOLUTION RATIFYING THE CONTRACT ENTERED INTO BY THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, WITH TWENTY TWELVE ENTERPRISES – ENOA ENTERPRISES FOR THE PURCHASE AND DELIVERY OF SPECIFIC FOOD SUPPLIES IN FAVOR OF DRUG TREATMENT AND REHABILITATION CENTER (TAHANAN) IN THE AMOUNT OF SEVENTEEN MILLION THREE HUNDRED SEVENTEEN THOUSAND AND THREE HUNDRED FIFTY PESOS (PHP17,317,350.00) COVERING THE PERIOD FROM APRIL 1, 2013 TO MARCH 31, 2014.

WHEREAS, the Quezon City Drug Treatment and Rehabilitation Center, herein referred to as TAHANAN, is a local government institution operated and maintained by the Office of the Vice Mayor, created and established to provide rehabilitation and treatment to all drug dependents in Quezon City which includes provision of food for the residents thereat;

WHEREAS, the residents at TAHANAN are all drug dependents ordered for confinement by the Regional Trial Court for rehabilitation and food is a very essential element for their proper treatment, deferment of which might result to grave impairment to health and even loss of life;

WHEREAS, there is a need to authorize TAHANAN, through the City Mayor, Honorable Herbert M. Bautista, to enter into a contract with Twenty Twelve Enterprises-ENOA Enterprises in compliance with the existing laws and pertinent regulations and for the immediate implementation thereof.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to ratify, as it does hereby ratify the contract entered into by the Quezon City Mayor, Honorable Herbert M. Bautista, with Twenty Twelve Enterprises-ENOA Enterprises for the purchase and delivery of specific food supplies in favor of Drug Treatment and Rehabilitation Center (TAHANAN) in the amount of Seventeen Million Three Hundred Seventeen Thousand and Three Hundred Fifty Pesos (Php17,317,350.00) for the period from April 1, 2013 to March 31, 2014.

RESOLVED, FURTHER, that a copy of this Resolution be forwarded to the Office of the Vice Mayor and the owner of Twenty Twelve Enterprises-ENOA Enterprises for their information, appropriate action and proper guidance.
