A RESOLUTION RATIFYING THE CONTRACT ENTERED INTO BY THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, WITH CULTURAL PUBLISHER FOR THE PURCHASE, SUPPLY AND DELIVERY OF SCHOOL TEXTBOOKS IN THE AMOUNT OF EIGHTEEN MILLION FIVE HUNDRED THIRTEEN THOUSAND SEVEN HUNDRED THIRTY-FOUR PESOS (PHP18,513,734.00) IN FAVOR OF THE QUEZON CITY DIVISION OF CITY SCHOOLS.
