RESOLUTION NO. SP- 5776, S-2013

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO EXTEND FINANCIAL ASSISTANCE IN BEHALF OF THE QUEZON CITY GOVERNMENT IN THE AMOUNT OF TWO MILLION PESOS (PHP2,000,000) TO THE VICTIMS OF THE 7.2 MAGNITUDE EARTHQUAKE IN THE PROVINCE OF BOHOL, TO BE TAKEN FROM THE DISASTER RISK REDUCTION MANAGEMENT FUND OF THE CITY OR ANY AVAILABLE FUNDS THEREOF.

WHEREAS, in the morning of October 15, 2013, at around 8:12, a 7.2 magnitude earthquake struck the province of Bohol and other nearby areas with the epicenter recorded in Carmen, Bohol;

WHEREAS, to date, the affected areas are still experiencing aftershocks and a total of 2,533 families are currently displaced and residing in evacuation centers;

WHEREAS, the province of Bohol was declared under the state of calamity on October 15, 2013 and all departments and government agencies were directed to implement and execute medical assistance, relief and rehabilitation work in accordance with existing operational plans and directives and orders in connection with the occurrence of calamities;

of Republic Act No. 10121 (The Philippine Disaster Risk Reduction and Management Act of 2010) provides that upon the recommendation of the LDRRMC and approval of the Sanggunian concerned, the LDRRMC may transfer the said fund to support the disaster risk reduction work of other LDRRMC's which are declared under the state of calamity.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to extend financial assistance in behalf of the Quezon City Government in the amount of Two Million Pesos (Php2,000,000.00) to the victims of the 7.2 Magnitude Earthquake in the Province of Bohol, to be taken from the Disaster Risk Reduction Management Fund of the city or any available funds thereof.
