RESOLUTION NO. SP- 5784, S-2013

A RESOLUTION ENDORSING THE CONSTRUCTION OF A TWO-STOREY MULTI-PURPOSE HALL WITHIN THE PREMISES OF THE UNIVERSITY OF THE PHILIPPINES TO BE FUNDED BY THE OFFICE OF COUNCILOR JESUS MANUEL C. SUNTAY.

WHEREAS, it is the policy of the Quezon City Government to provide its citizens with needed infrastructures to give them an avenue to conduct activities and events thereby fostering a sense of well-being and molding them into highly productive, self-reliant morally upright, educated and disciplined citizens;

WHEREAS, in furtherance of the said policy of the city, infrastructure projects will be built inside the property of the University of the Philippines (U.P.) in Barangay U.P. Campus as requested by its Punong Barangay Isabelita P. Gravides, specifically, a two-storey multi-purpose hall at Zone A, Pook Ricarte, among others;

WHEREAS, the building of a multi-purpose hall in Barangay U.P. Campus will provide a venue for public assemblies, gatherings, and other activities for the residents;

WHEREAS, the City Government recognizes the autonomy of the University of the Philippines as a chartered state university and honors its policies over their property;

WHEREAS, in the Memorandum issued by the University of the Philippines, among their requirements for the consideration and approval of the mentioned project is a resolution by the City Council attesting to the strong commitment of the City Government to build infrastructures that will contribute to the progress and development in the community;
