WHEREAS, Section 454 and Section 469 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, reaffirmed the creation of the Office of the Secretary to the Sangguniang Panlungsod;

WHEREAS, to provide a legal imprimatur to any documentation and establish its own identity, there is a need for the Office of the Secretary to the Sangguniang Panlungsod to have its own official seal.
