RESOLUTION NO. SP- 5791, S-2013

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO EXTEND FINANCIAL ASSISTANCE IN BEHALF OF THE QUEZON CITY GOVERNMENT IN THE AMOUNT OF FIFTY MILLION PESOS (PHP50,000,000.00) TO THE VICTIMS OF SUPER TYPHOON YOLANDA (HAIYAN) AT FORTY FOUR (44) PROVINCES OF REGIONS IV-A, IV-B, V, VI, VII, VIII, X, XI AND CARAGA AND TO SUPPORT THE RELIEF OPERATIONS OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FOR THE PROVINCES, CITIES AND MUNICIPALITIES AFFECTED DURING ITS ONSLAUGHT LAST NOVEMBER 8, 2013, TO BE TAKEN FROM THE QUEZON CITY DISASTER RISK REDUCTION MANAGEMENT FUND.

WHEREAS, Typhoon Yolanda (international name Haiyan), the world's strongest storm this year, made landfall in central Philippines on Friday, November 8, 2013. Haiyan, locally known as Yolanda, had built up winds of 134mph and gusts of 155mph before smashing the Philippines central islands;

WHEREAS, on November 8, 2013 at 4:40 AM Typhoon Yolanda made its first landfall over Guiuan, Eastern Samar. It further moved as it made its second landfall over Tolosa, Leyte at 7:00 AM and its third landfall over Dacbantayan, Cebu at about 9:40 AM. At 10:40 AM, Typhoon Yolanda made its fourth landfall over Bantayan Islands, Cebu and by 12:00 NN made its fifth landfall over Conception, Iloilo. In the afternoon, it maintained its strength as it approaches the Calamian Group of Islands and made its sixth landfall at 8:00 PM over Busuanga, Palawan. Typhoon Yolanda weakened as it continued to traverse over the West Philippine Sea and on November 9, 2013 at 3:30 PM, it was reported to be outside the Philippine Area of Responsibility;

WHEREAS, the National Disaster Risk Reduction Management Council (NDRRMC) Situational Report No. 26 (Effects of Typhoon Yolanda), dated November 18, 2013 disclosed that a total of 2,212,955 families or 10,306,318 persons were affected in 10,365 barangays in 574 municipalities and 57 cities in 44 provinces of Regions IV-A, IV-B, V, VI, VII, VIII, X, XI and CARAGA;

WHEREAS, out of the total 850,058 affected families, 4,008,894 persons were displaced and served both inside and outside evacuation centers;


WHEREAS, NDRRMC Situational Report No. 26 reported that the number of damaged houses increased to 571,806 houses (288,922 totally damaged/ 282,884 partially damaged);

WHEREAS, a total cost of damages pegged at Php10,384,690,061.00 with Php1,295,508,600.00 for infrastructures and Php9,089,181,461.00 for agriculture in Regions IV-A, IV-B, V, VI, VII, VIII and CARAGA;

WHEREAS, damage to livestock amounted to Php2,079,107,275.00 while a total of Php1,055,477,436.00 worth of damage to fisheries. Damage to irrigation facilities and other agricultural infrastructure amounted to the Php212,700,000.00 and Php1,134,277,600.00, respectively;

WHEREAS, President Benigno Aquino III declared Monday evening, November 11, 2013, a "state of national calamity" to speed up the relief and rehabilitation efforts in "Yolanda"- stricken areas in Eastern Visayas;


WHEREAS, Rule 18, Section 1 of the Implementing Rules and Regulations of Republic Act No. 10121 (the Philippine Disaster Risk Reduction and Management Act of 2010) provides that upon the recommendation of the LDRRMC and approval of the Sanggunian concerned, the LDRRMC may transfer the said fund to support the disaster risk reduction work of other LDRRMC's which are declared under state of calamity. NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to extend financial assistance in behalf of the Quezon City Government in the amount of fifty million pesos (Php50,000,000.00) to the victims of Super Typhoon Yolanda (Haiyan) at forty four (44) provinces of Regions IV-A, IV-B, V, VI, VII, VIII, X, XI and Caraga and to support the relief operations of the Department of Social Welfare and Development for the provinces, cities and municipalities affected during its onslaught last November 8, 2013, to be taken from the Quezon City Disaster Risk Reduction Management Fund.
