RESOLUTION NO. SP. 5794 , S-2013

A RESOLUTION AUTHORIZING THE CITY MAYOR HONORABLE HERBERT M. BAUTISTA, TO PURCHASE TEN (10) UNITS OF MOTORIZED VEHICLES IN THE AMOUNT OF FIVE MILLION NINE HUNDRED NINETY SIX THOUSAND TWO HUNDRED FIFTY PESOS (P5,996,250.00) TO BE TAKEN FROM THE FUNDS OF THE OFFICE OF THE MAYOR FOR MOBILITY IN THE CONDUCT OF INSPECTIONS, IMPROVING SERVICE, PRODUCTIVITY, EFFICIENCY AND CAPABILITIES OF THE DEPARTMENT OF THE BUILDING OFFICIAL.

WHEREAS, Section 455 (b) (1) (vi) of Republic Act No. 7160 provides that the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod pursuant to law or ordinance;

WHEREAS, the City Building Official requested the purchase of ten (10)/units of motorized vehicle amounting to Five Hundred Ninety Nine Thousand Six Hundred Twenty Five Pesos (P599,625.00) each with a total amount of Five Million Nine Hundred Ninety Six Thousand Two Hundred Fifty Pesos (P5,996,250.00);

WHEREAS, the specification of the motor vehicles are described as follows:

- Rear Suspension: Rigid Axle & Lead Spring:
- Steering: Rack & Pinion with Power Assist;
- Fuel Tank Capacity: 46 Liters;
- Single Air Condition system;
- 8 Passengers:
- Overall Length: 4,156 mm
 Overall Width: 1,655 mm
 Overall Height: 1,865 mm
 Ground Clearance: 175 mm
 Gross Vehicle Weight: 1,950 kg;

- Three (3) Years, Land Transportation Office Registration, Free of Charge;
- Third Party Liability (for LTO Registration);

- Three (3) years/ 100,000 kms. warranty whichever comes first.

WHEREAS, the purchase of the said vehicles shall be used for mobility in the conduct of inspections, improving service, productivity, efficiency and capability to efficiently discharge the mandated functions, duties and responsibilities of the Department of Building Official pursuant to Presidential Decree No. 1096 (National Building Code, as amended) and the Revenue Generation including visitorial powers of the Quezon City Government;

WHEREAS, pursuant to Administrative Order No. 15 amending Administrative Order No. 233 Series of 2008, the Honorable Mayor Herbert M. Bautista has already sought permission and authorization from the Department of the Interior and Local Government for the purchase of the above mentioned vehicles.
