RESOLUTION NO. SP- 5806, S-2013

A RESOLUTION URGING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO NEGOTIATE WITH THE GOVERNMENT SERVICE INSURANCE SYSTEM (GSIS) FOR THE ACQUISITION OF THE ONE THOUSAND NINE HUNDRED EIGHTY FOUR (1,984) SQUARE METERS PROPERTY OWNED BY THE LATTER IN FAIRLANE STREET, BARANGAY FAIRVIEW, THIS CITY, COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED RT-33258 (157254), RT-33259 (157255), RT-33260 (157256) AND RT-33261 (157257) AS A POTENTIAL SITE FOR THE CONSTRUCTION OF A PUBLIC HIGH SCHOOL.

WHEREAS, Section 2 (1) Article XIV, of the 1987 Constitution provides that the state shall establish, maintain, and support a complete, adequate, and integrated system of education relevant to the needs of the people and society;

WHEREAS, the Quezon City Government in its mission to provide a quality and affordable education, recognizes the importance of such in developing a progressive community thereby encourages its citizenry to be diligent and provide opportunities to them to persevere in their education in the hope of someday becoming an asset of the city; X

WHEREAS, a large barangay such as Barangay Fairview should have its own public school for the benefit of its constituents whom at the present travels to other barangays to attend high school:

WHEREAS, an integral part of realizing such goal is to determine a possible site for the construction of the school, which would provide opportunity for the city government to pursue its aim:

WHEREAS, a 1,984 sq. m. property owned by the Government Service Insurance System (GSIS) along Fairlane Street in Barangay Fairview is a possible site for the construction, depending on the outcome of the negotiations between the latter and the Quezon City Government.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the City Mayor, Honorable Herbert M. Bautista, to negotiate with the Government Service Insurance System (GSIS) for the acquisition of the One Thousand Nine Hundred Eighty Four (1,984) Square Meters property owned by the latter in Fairlane Street, Barangay Fairview, this City, covered by Transfer Certificates of Title Numbered RT-33258 (157254), RT-33259 (157255), RT-33260 (157256) and RT-33261 (157257) as a potential site for the construction of a Public High School.
