RESOLUTION NO. SP- 5810, S-2013

**A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A CONTRACT/AGREEMENT FOR THE PURCHASE OF GOODS TO BE DISTRIBUTED TO THE IMPOVERISHED FAMILIES OF QUEZON CITY AS PAMASKONG HANDOG IN THE TOTAL AMOUNT OF SIXTY SIX MILLION FOUR HUNDRED SIXTY EIGHT THOUSAND SEVEN HUNDRED FIFTY PESOS (PHP66,468,750.00).**

No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligation and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to a law or ordinance;*

*WHEREAS, the Office of the Mayor is requesting for authorization to enter into a contract/agreement for the purchase of goods for the annual Christmas gift giving activity of the city or Pamaskong Handog, in the total amount of sixty six million four hundred sixty eight thousand seven hundred fifty pesos (PHP66, 468,750.00);*

*WHEREAS, the commodities to be purchased will be given to the less fortunate families in Quezon City during the Christmas season through the Social Services Development Department;*



**BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED,** to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to enter into a contract/agreement for the purchase of goods to be distributed to the impoverished families of Quezon City as Pamaskong Handog, in the total amount of sixty six million four hundred sixty eight thousand seven hundred fifty pesos (Php66,468,750.00).

**RESOLVED, FURTHER,** that a copy of this Resolution be given to the City Budget Department, City Accounting Department, Commission on Audit-Quezon City Field Office, and Department of the Interior and Local Government for their information and guidance.
