A RESOLUTION AUTHORIZING THE CITY MAYOR OF QUEZON CITY TO ENTER INTO A CONTRACT/AGREEMENT WITH THE WINNING FIREARMS SUPPLIER-BIDDER FOR THE OFFICIAL USE OF THE QUEZON CITY POLICE DISTRICT, IN CONNECTION WITH THE MAINTENANCE OF PEACE AND ORDER IN QUEZON CITY.

WHEREAS, it is the policy of the Quezon City Government to ensure the safety and welfare of its people by providing our police personnel with all the necessary support to ensure operational efficiency;

WHEREAS, with the irrefutable logistical support extended by the Quezon City Government to the Quezon City Police District (QCPD) in the form of patrol vehicles, modern police equipment and precinct facilities, our police force has responded positively by improving the crime solution efficiency, deterring the commission of street crimes by greater police visibility, and producing honest and helpful police officers in our city, among others;

WHEREAS, in fact, President Benigno S. Aquino III has reported that the crime volume in the country improved from 319,441 incidents reported in 2010 to 217,812 in 2012; Carnapping incidents decreased by forty (40) percent, while kidnap-for-ransom cases also went down to seventy three (73) percent in the same year;

WHEREAS, in furtherance of maintaining peace and order in our city and for the purpose of attaining a 1:1 police-to-firearm ratio in the Philippine National Police, it is essential for the QCPD, through the Office of the Honorable Quezon City Mayor Herbert M. Bautista, to enter into contract with the winning bidder of the firearms supplier for this project;

WHEREAS, an Approved Budget Contract in the amount of Seventeen Million Three Hundred Eighty Thousand One Hundred Sixty Pesos (PHP17, 380, 160.00) is already available for this project as shown by supported documents.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor of Quezon City to enter into a contract/agreement with the winning firearms supplier-bidder for the official use of the Quezon City Police District, in connection with the maintenance of peace and order in Quezon City.
