- Big rear step board to accommodate fire fighter personnel
- Fire hose 1 1/2 x 100 double jacket

WHEREAS, among the several documents needed for the acquisition of the said firetrikes is a resolution of the City Council authorizing the City Mayor to enter into a contract with the winning bidder who will deliver the equipment.
