RESOLUTION NO. SP. 5822 S-2013

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO FITTER INTO A CONTRACT/AGREEMENT FOR THE PURCHASE OF TWO (2) UNITS OF FOUR-WHEEL MODEL HYDRAULIC PRE-HEATER *IN* THE TOTAL **AMOUNT** DOUBLE-CYCLINDER THOUSAND SIX **HUNDRED** PESOS TWELVE MILLION (PHP12,600,000.00), INTENDED FOR MAKING THE REFLECTORIZED PAINT TO BE USED AS LANE MARKERS ON THE THOROUGHFARES OF QUEZON CITY, TO BE UTILIZED BY THE QUEZON CITY ENGINEERING DEPARTMENT.



WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise lawwn as the Local Government Code of 1991, the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligation and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to a law or ordinance;

WHEREAS, the Office of the City Mayor is requesting for authorization to enter into a contract/agreement for the purchase of two (2) units of four-wheel model hydraulic double-cylinder pre-heater in the total amount of twelve million six hundred thousand pesos (PHP12,600,000.00), with the following description/specification:

DY-FHDP-I four-wheel model hydraulic double-cylinder pre-heater

189HP Aircooled One cylinder Diesel Engine;





- Hydraulic Stirring System with protective device 225Lx2;
- LPG, energy-sufficient Burner;
- 1660mmx1600mmx1850mm;
- 1720kg
- Including trailer

WHEREAS, the purchase of the said equipment shall be utilized by the Quezon City Engineering Department for making the reflectorized paint to be used as lane markers within the thoroughfares of the city;

WHEREAS, granting this authorization to the city mayor will definitely help the improvement of city roads, thus boosting investment, trade, and commerce within the city.

## NOW, THEREFORE,

BE 1T RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to enter into a contract/agreement for the purchase of two (2) units of four-wheel model hydraulic double-cylinder pre-heater in the total amount of twelve million six hundred thousand pesos (PHP12,600,000.00), intended for making the reflectorized point to be used as lane markers on the thoroughfures of Quezon City, to be utilized by the Quezon City Engineering Department;

RESOLVED, FURTHER, that a copy of this Resolution be given to the City Budget Department, City Accounting Department, Commission on Audit-Quezon City Field Office and Department of the Interior and Local Government for their information and guidance.
