RESOLUTION NO. SP- 5826, S-2013

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A CONTRACT FOR THE PURCHASE OF BITUMINOUS PRIME COAT AND BITUMINOUS CONCRETE SURFACE COARSE INTENDED FOR ASPHALT PATCHING (FD) AND OVERLAY (FDLRC) OF DAMAGED ROADS IN QUEZON CITY.

WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991," the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligation and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to a law or ordinance;

WHEREAS, granting this authorization to the city mayor will help the city in preserving its roads, alleviating traffic congestion, and easing transportation of both people and goods, thus further enhancing investment, trade, and commerce in Quezon City;

WHEREAS, the Office of the City Mayor is requesting for authorization to enter into a contract for the purchase of thirty (30) units of Bituminous Prime Coat and three thousand (3,000) units of Bituminous Concrete Surface Coarse, in the total amount of sixteen million six hundred fifty three thousand nine hundred ninety two pesos and seventy centavos (PHP16, 653,992.70), to be used for the asphalt patching project (FD) of the city, and for the purchase of one hundred (100) units of Bituminous Prime Coat and ten thousand (10,000) units of Bituminous Concrete Surface Coarse, in the total amount of fifty nine million one hundred fifty thousand two hundred nine pesos (PHP59,150,209.00), to be used for the asphalt overlay project (FDLRC) of the city;

WHEREAS, the City Budget Department has certified that funds are available for the project;


WHEREAS, the purchase of the said construction materials shall be utilized by the Quezon City Engineering Department for the maintenance and restoration of damaged thoroughfares of the city.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to enter into a contract for the purchase of bituminous prime coat and bituminous concrete surface coarse intended for asphalt patching (FD) and overlay (FDLRC) of damaged roads in Quezon City;

RESOLVED, FURTHER, that a copy of this Resolution be given to the City Budget Department, City Accounting Department, Commission on Audit-Quezon City Field Office, and Department of the Interior and Local Government for their information and guidance.


