RESOLUTION NO. SP- 5827, S-2013

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE INTENDED FOR MONITORING THE PROGRAMS AND PROJECTS OF THE OFFICE OF COUNCILOR ANDRES JOSE G. YLLANA JR., AMOUNTING TO NINE HUNDRED EIGHTY THOUSAND PESOS (P980,000.00), TO BE CHARGED AGAINST THE FUNDS OF THE OFFICE OF THE CITY MAYOR.


NOW, THEREFORE,


