A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO FILIPINAS SHELL PETROLEUM CORPORATION, FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE FILLING STATION TO BE LOCATED AT NO. 1069 EDSA, BARANGAY KATIPUNAN, DISTRICT I, QUEZON CITY.

WHEREAS, petitioner, Pilipinas Shell Petroleum Corporation, a business entity duly registered under Philippine laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a Gasoline Filling Station located at No. 1069 EDSA, Barangay Katipunan, District I Quezon City;

WHEREAS, fuel stations are among the uses that require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-2200, S-2013, otherwise known as the Revised Quezon City Comprehensive Zoning Ordinance (Series of 2013);


WHEREAS, Pilipinas Shell Petroleum Corporation has complied with the necessary requirements for the issuance of a Special Use Permit as mandated by the Quezon City Comprehensive Zoning Ordinance;

WHEREAS, the construction and operation of a gas station will provide employment and promote economic development in the city.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Special Use Permit to Pilipinas Shell Petroleum Corporation for the construction and operation of a Gasoline Filling Station to be located at No. 1069 EDSA, Barangay Katipunan, District 1, Quezon City.
