RESOLUTION NO. SP. 5831 , S-2013

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A CONTRACT WITH IPM ENVIRONMENTAL SERVICES, INC. FOR THE EXTENSION OF SERVICES FOR THE INTEGRATED SOLID WASTE MANAGEMENT FACILITY PROJECT AMOUNTING TO TWO HUNDRED FORTY MILLION EIGHT HUNDRED NINETY SEVEN THOUSAND EIGHT HUNDRED TEN PESOS (PHP240,897,810.00).

WHEREAS. Section 458 (5) (xiii) of Republic Act No. 7160, otherwise known on the "Local Government Code of 1991", mandates the City Council to provide for efficient and effective system of solid waste and garbage collection and disposal;

WHEREAS, pursuant to the abovementioned mandate, the Quezon City-Government established the "Integrated Solid Waste Management Facility Project";

WHEREAS, to bring about the full fruction of the "Integrated Solid Waste Management Facility Project," the Quezon City Government entered into a "Solid Waste Management Facility Agreement" With Ipm Environmental Services, Inc. on 14 February 2011 for the rendition of services by the latter for the period of 01 January 2011 to 31 December 2013; A

WHEREAS, the Environmental Protection and Waste Management Department (EPWMD) requested the City Mayor, Honorable Herbert M. Bautista for the six (6) month extension of the contract with the same service provider considering that it is in the first three (3) months of the year where the highest volume of garbage collection is recorded in the City and new contractors may still need to adapt with the City's system of collection and deployment schedule;

WHEREAS, the City Mayor, Honorable Herbert M. Bautista, approved the request and recommendation of the EPWMD;

WHEREAS, Section 22 of the "Local Government Code of 1991" requires the prior authorization from the City Council before the local chief executive can enter into a contract on behalf of the local government unit.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUETON CITY IN SPECIAL SESSION ASSEMBLED, to authorize as it does hereby authorize the City Mayor. Honorable Herbert M. Bautista, to enter into a contract with IPM Environmental Services, Inc. for the extension of services for the Integrated Solid Waste Mayagement Facility Project amounting to two hundred forty million eight hundred nivety seven thousand eight hundred ten peros (Php240,897,810.00).

RESIDEVED. FURTHER, that a copy of the Solid Waste Management Facility Agreement he made an integral part of this Resolution.
