RESOLUTION NO. SP- **5832**, S-2013

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A CONTRACT WITH LEG HAULING SERVICES CORPORATION; ACY TRANSPORT CORPORATION; OMNI HAULING SERVICES INCORPORATED; IPM CONSTRUCTION & DEVELOPMENT CORPORATION; 316 METRO TRANSPORT, INC. AND HALREY CONSTRUCTION, INCORPORATED FOR THE EXTENSION OF SERVICES FOR THE SOLID WASTE COLLECTION CLEANING AND DISPOSAL SERVICES AMOUNTING TO ONE HUNDRED NINETY FOUR MILLION ONE HUNDRED FOURTEEN THOUSAND FIVE PESOS AND FORTY ONE CENTAVOS (PH194,114,005.41).

WHEREAS Section 458 (5) (xiii) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", mandates the City Council to provide for efficient and effective system of solid waste and garbage collection and disposal;

WHEREAS, pursuant to the abovementioned mandate, the Quezon City Government established the "Solid Waste Collection Cleaning and Disposal Services";

WHEREAS, to bring about the full fruition of the "Solid Waste Collection Cleaning and Disposal Services," the Quezon City Government entered into a "solid waste cleaning, collection and disposal service agreement" with Halrey Construction, Incorporated; 316 Metro Transport, Inc.; IPM Construction & Development Corporation; Omni Hauling Services, Incorporated; ACY transport Corporation; and Leg Hauling Services Corporation on 03 January 2013 for the rendition of services by the latter for the period of 01 January 2013 to 31 December 2013; *A* *A* *S* *D*

WHEREAS, the Environmental Protection and Waste Management Department (EPWMD) requested the Honorable Quezon City Mayor Herbert M. Bautista for three (3) month extension of the contract with the same service providers considering that it is in the first three (3) months of the year where the highest volume of garbage collection is recorded in the City and new contractors may still need to adapt with the City's system of collection and

WHEREAS, Honorable Quezon City Mayor Herbert Bautista approved the request and recommendation of the EPWMD;

WHEREAS, Section 22 of the "Local Government Code of 1991" requires the prior authorization from the City Council before the local chief executive can enter into a contract on behalf of the local government unit.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN A SPECIAL SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to enter into a contract with Leg Hauling Services Corporation; ACY Transport Corporation; Omni Hauling Services Incorporated; IPM Construction & Development Corporation; 316 Metro Transport, Inc. OMNI and Halrey Construction, Incorporated for the extension of services for the Solid Waste Collection Cleaning and Disposal Services amounting to one hundred ninety four million one hundred fourteen thousand five pesos and forty one centavos (Php194,114,005.41).

RESOLVED, FURTHER, that a copy of the Solid Waste Cleaning, Collection and Disposal Service Agreement be made an integral part of this Resolution.
