**A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A CONTRACT FOR THE PURCHASE OF THIRTY FIVE THOUSAND FOUR HUNDRED FIFTY EIGHT (35,458) UNITS OF LEARNER'S KIT TO BE UTILIZED FOR TEACHING GRADES FOUR (4) AND FIVE (5) PUBLIC SCHOOL PUPILS OF QUEZON CITY.**

*WHEREAS, the City Mayor is requesting for authorization to enter into a contract/agreement for the purchase of 35,458 units of Learner's Kit for Grades Four (4) and Five (5) pupils with the total acquisition cost of Seventeen Million One Hundred Ninety Seven Thousand One Hundred Thirty Pesos (Php17,197,130.00) with the following specifications:*

*WHEREAS, the purchase of the said learner's kit shall be utilized by the Public Schools in Quezon City for the conduct of classroom lessons to their students.*


**NOW, THEREFORE,**
