RESOLUTION NO. SP- 5839, S-2013

**A RESOLUTION GRANTING A SPECIAL PERMIT TO B-7 AMUSEMENT CORPORATION FOR THE ESTABLISHMENT AND OPERATION OF A BINGO HALL AT NOVA MARKET (FORMERLY ROBINSON'S PLACE NOVALICHES), QUIRINO HIGHWAY, NOVALICHES, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION.**

*WHEREAS, B-7 Amusement Corporation was previously granted a Special Permit under Resolution No. SP-4119, S-2008, to establish and operate a Bingo Hall at Nova Market, Novaliches, Quezon City;*

*WHEREAS, PAGCOR, pursuant to Presidential Decree No. 1869, executed the Amendment to Grant of Authority to Operate Bingo Games dated 10 June 2010 extending B-7 Amusement Corporation's until 24 June 2015;*

*WHEREAS, in recognition of the authority of PAGCOR to regulate the operation of a bingo hall, and upon proof of such authority, the City Council has previously allowed the operation of bingo halls through Special Permits pursuant to its powers under Republic Act No. 7160 to authorize the issuance of permits or licenses.*

**NOW, THEREFORE,**

**BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN A SPECIAL SESSION ASSEMBLED,** to grant, as it does hereby grant a Special Permit to B-7 Amusement Corporation for the establishment and operation of a Bingo Hall at Nova Market (formerly Robinson's Place Novaliches), Quirino Highway, Novaliches, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation.

**RESOLVED, FURTHER,** that B-7 Amusement Corporation shall secure a Mayor's Permit for the operation of the Bingo Hall and that the authority granted herein shall be subject to the following limitations: >


*AS* *to*

- a. The holding of bingo games shall be in accordance with the rules and regulations as promulgated by PAGCOR;
- b. The operation of the bingo hall shall not include the playing of games not related to bingo;


**RESOLVED, FURTHERMORE**, that this Special Permit shall be subject to the presentation by B-7 Amusement Corporation of the pertinent Grant of Authority to operate bingo from the Philippine Amusement and Gaming Corporation, including any extension thereto;

**RESOLVED, FINALLY**, that B-7 Amusement Corporation shall remit to the City Treasurer a franchise fee of three percent (3%) of the gross revenue of B-7 Amusement Corporation for such operation which shall be imposed and made payable yearly during the two (2) year period of the Special Permit.
