A RESOLUTION GRANTING A SPECIAL PERMIT TO THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION TO OPERATE AN INTERNET CASINO THROUGH AN ACCREDITED INTERNET OPERATOR, B-7 AMUSEMENT CORPORATION, AT THE UPPER GROUND FLOOR, BERKELEY SQUARE, COMMONWEALTH AVENUE CORVER TANDANG SORA AVENUE, BARANGAY MATANDANG BALARA, QUEZON CITY.

Introduced by Councilor FRANZ S. PUMAREN.

WHEREAS, the Philippine Amusement and Gaming Corporation (PAGCOR), a duly accredited/registered entity, is applying for a Special Permit from the City Council as a requirement for the issuance of business permit pursuant to Resolution No. SP-5236, S-2011;

WHEREAS, the applicant is authorized to operate an accredited Internet Casino Station (ICS) through an accredited internet operator, B-7 Amusement Corporation, pursuant to the provisions of Presidential Decree No. 1869;

WHEREAS, the applicant is applying for a Special Permit to operate an Internet Casino Station at the Upper Ground Floor, Berkeley Square, Commonwealth Avenue corner Tandang Sora Avenue, Barangay Matandang Balara, Quezon City.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN A SPECIAL REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant a Special Permit to the Philippine Amusement and Gaming Corporation to operate an Internet Casino through an accredited internet operator, B-7 Amusement Corporation at the Upper Ground Floor, Berkeley Square, Commonwealth Avenue corner Tandang Sora Avenue, Baranzay Matandang Balara, Quezon City.

RESOLVED FURTHER, that the Philippine Amusement and Gaming Corporation (PAGCOR) shall remit to the City Treasurer in lieu of all business taxes, a franchise fee of three percent (3%)of the gross revenue of herein grantee, which shall be made payable yearly to the City Treasurer's Office during the term of this measure.

RESOLVED, FINALLY, that the authority herein granted shall be for a period of two (2) years and maybe renewed by the City Council.
