RESOLUTION NO. SP. 5841 S-2013

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH SAN PEDRO IX SUBDIVISION HOMEOWNERS ASSOCIATION, INC. REPRESENTED BY ITS PRESIDENT ENGINEER GODOFREDO SANCHEZ, FOR THE SUPERVISION, MAINTENANCE, SECURITY AND UTILIZATION OF ROADS, EASIMENTS AND ALLEYS IN SAN PEDRO IX SUBDIVISION, BARGNGAY BAGBAG, QUEZON CITY.

WHEREAS, faithful to the State's policy as embodied in Sections 2 and 10 (c) and (d) of Republic Act No. 9904, otherwise known as "Magna Carta for Homeowners and Homeowners' Associations:"

## "XXX"

To this end, the State shall endeavor to make available resources and assistance that will help them fulfill their roles in serving the needs and interests of their communities, in complementing the efforts of local government policies, programs, rules and ordinances for the development of the nation.

#### XXX

(c) Regulate the use, maintenance, repair, replacement and modification of common areas and cause additional improvements to be made part of the common areas; Provided, That the aforementioned do not contradict the provisions of the approved subdivision plan;

(d) Regulate access to, or passage through the subdivision/village roads for purposes of preserving privacy, tranquility, internal security, and safety and traffic order: Provided, that (1) public consultations are held; (2) existing laws and regulations are met; (3) the authority of the concerned government agencies or units are obtained; and (4) the appropriate and necessary memoranda of agreement are executed among the concerned parties;"

WHEREAS, San Pedro IX Subdivision Homeowners Association Inc., herein represented by Engineer Godofredo Sanchez is a duly organized and registered non-stock, non-profit corporation composed of bona fide trembers and occupants of San Pedro IX Subdivision;

WHEREAS, San Pedro IX Subclivision Homeowners Association Inc., recognizes the rights and powers of the Quezon City Government as the true and registered owner of open spaces, easements and alleys within San Pedro IX Subdivision by virtue of a Deed of Donation entered into by the Quezon City Government and Labrador Development Corporation on 18 June 1990;

WHEREAS, in furtherance of the aforementioned state policies, San Pedro IX Homeowners Association Inc., seeks concessions from the Quezon City Government that they be authorized to exercise joint administration over the said open spaces, easiments and alleys by viay of adopting appropriate maintanance and security measures and allowing free and sensible use and access over subject premises, assuming all appurtenant expenses that such undertakings entail and ensuring that such measures for joint administration shall be with prior approval of the Quezon City Government and within the bounds of applicable laws:

WHEREAS, toward this end, San Pedro IX Subdivision Inc., wishes to enter into contract with the Quezon City Government through a Memorandum of Agreement which shall enumerate with specificity the limits of the proposed joint administration between the two parties:

WHERE 4S, Honorable Mayor Herhert M. Bautista, in his capacity as the local chief executive shall represent the Quezon City Government in this proposed joint undertaking;

WHEREAS, Section 22 (c) of Republic Act No. 7160, otherwise known as "The Local Government Code of 1991" laid out the prerequisites before the local chief executive can enter into a contract:

#### XXX

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A ligible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall."

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SPECIAL SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to enter into a Memorandum of Agreement with San Pedro IX Subdivision Homeowners Association, Inc. herein represented by its president Engineer Godofredo Sanchez, for the supervision, maintenance, security and utilization of roads, easements and alleys in San Pedro IX Subdivision, Barangay Sagbay, Quezon City.

RESOLVED, FURTHER, that the Memorandum of Agreement be made an integral part of this Resolution.
