A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH ARANETA CENTER. INC., FOR THE FREE USE OF AN AREA AT THE ALI MALL GOVERNMENT CENTER, LEVEL 2, CUBAO, THIS CITY, WHICH WILL FUNCTION AS A SATELLITE/EXTENSION OFFICE (ONE-STOP SHOP) FOR PAYMENT OF BUSINESS AND OTHER TAXES AS WELL AS OTHER AUXILIARY SERVICES.

WHEREAS, the Quezon City Government aims to bring government service closer to the people and deliver basic services more efficiently by promoting partnership with the private sector;

WHEREAS, Araneta Center, Inc. (ACI) is the owner and operator of Ali Mall and has agreed to allocate and provide a specific area inside its "Ali Mall Government Center" to be used by the City Government for putting up a Satellite/Extension Office;

WHEREAS, ACI is willing to waive the rental fees of the Satellite/Extension Office during the term of this Agreement for the benefit of mall patrons, visitors, clients and the general public as a whole;

WHEREAS, Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the City Mayor shall:

"Represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance."

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to enter into a Memorandum of Agreement (MOA) with Araneia Center, Inc., for the free use of an area at the Ali Mall Government Center, Level 2, Cubao, this city, which will function as a satellite/extension office (one-stop shop) for payment of business and other taxes as well as other auxiliary services.

RESOLVED, FURTHER, that a copy of the Memorandum of Agreement shall form an integral part of this resolution.
