WHEREAS, the City Council may authorize the Honorable Mayor to sell the motorized vehicle assigned to Ms. Villanueva subject to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 and its Implementing Rules and Regulations and other laws, rules and regulations.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Villanueva, Officer—In-Charge, Administrative Management Office (AMO) the motorized vehicle with License Plate Number SHL-804 registered under the name of the Quezon City Government, assigned to her at a reasonable cost to be determined by the Appraisal Committee subject to existing laws, rules and regulations.
