RESOLUTION NO. SP- 5894 , S-2014

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A CONTRACT WITH THE WINNING BIDDER FOR THE PURCHASE OF VARIOUS CONSTRUCTION MATERIALS AND SUPPLIES INTENDED FOR LAND MARKING OF SCHOOLS, CITY STREETS AND MARKETS IN QUEZON CITY AMOUNTING TO SIXTEEN MILLION EIGHT HUNDRED NINETY ONE THOUSAND PESOS (PHP 16,891,000.00).

WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991," the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, granting this authorization to the city mayor will help the city in ensuring that proper land and/or street markings are put in place for schools, various city streets and public markets for the guidance of the general public;

WHEREAS, the Office of the City Mayor is requesting for authorization to enter into a contract with the winning bidder for the purchase of Thermoplastic marking compounds (white and green), traffic paint primer, paint thinner, heavy duty gloves and calcomine amounting to sixteen million eight hundred ninety one thousand pexos (Phpl 6,891,000.00);

WHEREAS, the purchase of the said construction materials shall be utilized by the Department of Public Order and Safety (DPOS) for the said land markings.

NOW THEREFORE.

REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to enter into a contract with the winning bidder of various construction materials and supplies intended for the land marking of schools, city streets and markets in Quezon City amounting to Sixteen Millian Eight Flundred Ninety One Thousand Pesos (Php16,891,000.00).
