RESOLUTION NO. SP- 5895 S-2014

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A CONTRACT/AGREEMENT FOR THE PURCHASE OF GROCERY GOODS TO BE DISTRIBUTED TO THE IMPOVERISHED CONSTITUENTS OF QUEZON CITY AS PAMASKONG HANDOG AMOUNTING TO FIFTEEN MILLION SIX HUNDRED FIFTY TWO THOUSAND TWO HUNDRED PESOS (PHP 15,652,200.00).

WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, the Office of the Mayor is requesting for authorization to enter into a contract/agreement for the purchase of grocery goods in congruent to the Christmas gifl giving tradition of the city known as the "Pamaskong Handog", amounting to Fifteen Million Six Hundred Fifty Two Thousand Two Hundred Pesos (Php.) 5,652,200.00);

WHEREAS, each bag of "Pamaskong Handog" contains rice, macaroni, evaporated milk, chocolate rice porridge mix, coffee mix, powdered seasoning, sausage, corned beef, meat loaf, tuna in can and ready to serve food item;

WHEREAS, the commodities to be purchased will be given to the less fortunate constituents in Quezon City in view of the Christmas season to be spearheaded by the Social Services Development Department (SSDD).

## NOW THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to enter into a contract/agreement for the purchase of grocery goods to be distributed to the impoverished constituents of Quezon City as Pamaskong Handog, amounting to Fifteen Million Six Hundred Fifty Two Thousand Two Hundred Pesos (Php15,652,200.00);

RESOLVED, FURTHER, that copy of this Resolution be given to the City Budget Department, City Accounting Department, Commission on Audit-Quezon City Field Office, and Department of the Interior and Local Government for their information and guidance.
