A RESOLUTION URGING THE CITY GOVERNMENT TO STRICTLY IMPLEMENT THE BENEFITS GRANTED UNDER ORDINANCE NO. SP-637, S-98, AS PROVIDED FOR UNDER REPUBLIC ACT NO. 7305, OTHERWISE KNOWN AS "THE MAGNA CARTA OF PUBLIC HEALTH WORKERS", TO ALL PUBLIC HEALTH WORKERS OF NOVALICHES DISTRICT HOSPITAL.

WHEREAS, on February 17, 1998, the Quezon City Council enacted City Ordinance No. SP-637, S-98 granting benefits to public health workers under the Quezon City General Hospital and Quezon City Health Department as provided for under Republic Act No. 7305, otherwise known as "The Magna Carta of Public Health Workers";


WHEREAS, when the said Ordinance was enacted by the Quezon City Council the, public health workers under the Novaliches District Hospital was not specifically included therein because the said hospital was still an annex hospital of the Quezon City General Hospital; /

WHEREAS, since the Novaliches District Hospital is now a separate entity from the Quezon City General Hospital, all the benefits being granted to public health workers under the Quezon City General Hospital and Quezon City Health Department should also be granted to public health workers under the Novaliches District Hospital from the time it was created.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the City Government to strictly implement the benefits granted under Ordinance No. SP-637, S-98, as provided for under Republic Act No. 7305, otherwise known as "The Magna Carta of Public Health Workers", to all Public Health Workers of Novaliches District Hospital.
