RESOLUTION NO. SP- 5913 , S-2014

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A CONTRACT WITH THE WINNING BIDDER (GREEN SPOT DEVELOPMENT, INC.) FOR THE PURCHASE OF BITUMINOUS TACK COAT AND BITUMINOUS CONCRETE SURFACE COARSE, AMOUNTING TO THIRTY-SEVEN MILLION FOUR HUNDRED FIFTEEN THOUSAND NINE HUNDRED SEVENTY PESOS AND TWENTY-SEVEN CENTAVOS (PHP 37,415,970.27), INTENDED FOR THE RESTORATION OF TYPHOON DAMAGED STREETS IN QUEZON CITY.

WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, the Office of the City Mayor is requesting for authorization to enter into a contract with the winning bidder for the purchase of 67.40 metric tons of Bituminous Tack Coat and 6,740 metric tons of Bituminous Concrete Surface Coarse amounting to thirty-seven million four hundred fifteen thousand nine hundred seventy pesos and twenty-seven centavos (Php37,415,970.27);

WHEREAS, the purchase of the said construction materials shall be utilized by the Quezon City Engineering Department pursuant to the Road Maintenance Service Program specifically for the purpose of asphalt patching (FD) and restoring damaged roads all over Quezon City after Typhoon Maring and Habagat;

WHEREAS, granting this authorization to the city mayor will help in the maintenance and restoration of damaged city streets, thus further enhancing investment, trade, and commerce of Quezon City;

WHEREAS, the City Budget Department has certified the availability of funds to be utilized for this program.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to enter into a contract with the winning bidder (Green Spot Development, Inc.) for the purchase of bituminous tack coat and bituminous concrete surface coarse, amounting to thirty-seven million four hundred fifteen thousand nine hundred seventy pesos and twenty-seven centavos (Php37,416,970.27) intended for the restoration of typhoon damaged streets in Quezon City.

RESOLVED, FURTHER, that a copy of this Resolution be given to the City Budget Department, City Accounting Department, Commission on Audit-Quezon City Field Office, and Department of the Interior and Local Government for their information and guidance.
