WHEREAS, the Quezon City Government has been holding sensitive offices within and outside the city hall compound which needs the services of security providers in order to maintain peace and order within its premises as well as to protect its properties and the well-being of its employees;

WHEREAS, an Approved Budget Contract in the amount of One Hundred Fifty Two Million Six Hundred Forty Pesos (PHP152,000,640.00) is already available for this project as shown by supporting documents; X


WHEREAS, Lockheed Security and Investigation Agency, Inc., Marban Security and Investigation Agency, Inc. and Advance Forces Security and Investigation Services, Inc. are the winning bidders for the security packages;

WHEREAS, the said purchase request is in accordance with Republic Act Government.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to ratify, as it does hereby ratify the contract entered into by and between the Quezon City Government represented by the City Mayor, Honorable Herbert M.
