RESOLUTION NO. SP- **5941**, S-2014

A RESOLUTION AUTHORIZING THE CITY MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, THE METROPOLITAN MANILA DEVELOPMENT AUTHORITY AND MALLERS INVESTMENT CORPORATION FOR THE CONSTRUCTION OF A PEDESTRIAN FOOTBRIDGE ALONG QUEZON AVENUE NEAR ROOSEVELT AVENUE, QUEZON CITY.

WHEREAS, the Department of Public Works and Highways (DPWH) is the engineering and construction arm of the National Government mandated to design, plan and undertake the construction of infrastructure facilities such as roads and bridges, including research and technology development to ensure quality, safety and efficiency of said facilities;

WHEREAS, the Metropolitan Manila Development Authority (MMDA) has jurisdiction in the Metropolitan Manila area over transportation and traffic management, solid waste disposal, flood control and sewerage management, urban planning and renewal, zoning, land use planning, health, sanitation, pollution control, public safety and similar undertakings;

WHEREAS, the City Mayor is the head and representative of the City mandated under Section 455 (b)(4)(i) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, to ensure that the construction and repair of roads and highways funded (or authorized) by the National Government is carried out in a spatially contiguous manner and in coordination with the construction and repair of roads in the City;

WHEREAS, Mallers Investment Corporation (MIC) owns and operates the Fisher Mall located at Quezon Avenue corner Roosevelt Avenue, Quezon City;


WHEREAS, foot traffic in the Fisher Mall area is expected to rise significantly where shoppers, including pedestrian and commuters must cross Quezon Avenue to reach the mall premises, thereby contributing to heavy traffic while placing life and limb at risk;

WHEREAS, MIC proposes, as it in fact requested authority from the Sanggunian Panlungsod, to construct a footbridge at its own expense along Quezon Avenue to address the expected increase of foot traffic for the safety of motorists and pedestrians alike.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor to represent the Local Government of Quezon City in a Memorandum of Agreement with DPWH, MMDA and MIC for the construction of a footbridge at the expense of the latter in front of Fisher Mall along Quezon Avenue near Roosevelt Avenue under reasonable terms and conditions with the best interest of the City and its constituents as primary consideration.
