RESOLUTION NO. SP- 5968, S-2014

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE IN THE AMOUNT OF FIVE HUNDRED NINETY SIX THOUSAND PESOS (PHP596,000.00), INTENDED TO FACILITATE THE IMPLEMENTATION OF THE PROGRAMS AND PROJECTS OF THE DIVISION OF CITY SCHOOLS OF QUEZON CITY TO BE CHARGED AGAINST THE FUNDS OF THE OFFICE OF COUNCILOR JESUS MANUEL C. SUNTAY.

WHEREAS, under Section 2, Article 1 of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, it is the policy of the State of promote the ideals of good governance in all its branches, departments, agencies, subdivisions and instrumentalities including government-owned and controlled corporations and local government units;

WHEREAS, the Division of City Schools was recognized by the Department of Education established primarily to exercise general supervision over both public and private elementary and secondary schools in Quezon City;

WHEREAS, to ensure that such function be fully performed by the said office, there is an imperative need to provide them the necessary motor vehicles;

WHEREAS, the Office of Councilor Jesus Manuel C. Suntay desires to procure one (1) unit of all-purpose Vehicle (APV) GA to be used for the aforesaid purposes, with the following general specifications:

WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to a law or ordinance.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to purchase one (1) unit of motor vehicle in the amount of Five Hundred Ninety Six Thousand Pesos (Php596,000.00), intended to facilitate the implementation of the programs and projects of the Division of City Schools of Quezon City, to be charged against the funds of the Office of Councilor Jesus Manuel C. Suntay.

RESOLVED, FURTHER, that a copy of this Resolution be given to the City Budget Department, City Accounting Department, Commission on Audit-Quezon City Field Office, and Department of the Interior and Local Government for their information and guidance.
