WHEREAS, the award is given to individuals, non-government organizations, private sectors and government organizations, in recognition of their initiative in helping the Filipino government uplift the standard of disaster management in the country;

WHEREAS, on December 9, 2016 Undersecretary Thomas M. Orbos, General Manager of Metropolitan Manila Development Authority and Officer-In-Charge, Metro Manila Disaster Risk Reduction and Management Council, awarded the Plaque of Recognition to Barangay Sto. Cristo Quezon City for the best Barangay Disaster Risk Reduction Management (BDRRM) Committee;




