RESOLUTION NO. SP- **6992**, S-2017

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA TO ENTER INTO CONTRACT/ AGREEMENT WITH THE PROSPECTIVE WINNING BIDDERS FOR VARIOUS INFRASTRUCTURE PROJECTS IN QUEZON CITY.

WHEREAS, Section 22 (c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without the prior authorization by the Sanggunian concerned";

WHEREAS, Section 455 (b) (1) (vi) of the same Code provides that "the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance";

WHEREAS, the Office of the City Mayor is requesting for authorization to enter into contract/ agreement with the prospective winning bidders for various infrastructure projects (Project No. 1610001) specifically described as follows:


