A RESOLUTION GRANTING A MARKET FRANCHISE TO "ARANETA CENTER, INC." TO CONTINUE THE OPERATION OF THE EXISTING FARMERS MARKET LOCATED AT THE ARANETA CENTER, CUBAO, QUEZON CITY, IN ACCORDANCE WITH AND SUBJECT TO THE PERTINENT PROVISIONS OF ORDINANCE NO. SP-2459, S-2015, OTHERWISE KNOWN AS THE REVISED QUEZON CITY MARKET CODE.

WHEREAS, on January 30, 1967, the Quezon City Council adopted Resolution No. 7350, S-67, authorizing the "Progressive Development Corporation" to establish and operate a market at the Araneta Center, Cubao, Quezon City, with permit to sell fresh meat, fish, poultry and other articles of food for a period of ten (10) years;

WHEREAS, on October 7, 1982 the then Metro Manila Council granted authority to the "Progressive Development Corporation" to operate the Farmers Market for the period from the date of expiration of the original authority up to the end of calendar year 1987; x

WHEREAS, on November 18, 1991, the Quezon City Council adopted Resolution No. NC-617, S-91 granting authority to the "Progressive Development Corporation" to continue the operation of the existing Farmers Market located at the Araneta Center, Cubao, Quezon City, previously authorized under Resolution No. 7350, S-67, subject to certain conditions;

WHEREAS, Araneta Center, Inc., formerly "Progressive Development Corporation", intends to continue the operation of Farmers Market which for Fifty (50) years have served the needs of the residents of Quezon City and its continued operation is to the best interest of the City.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant a market franchise to the "Araneta Center, Inc". to continue the operation of the existing Farmers Market located at the Araneta Center, Cubao, Quezon City, in accordance with and subject to the pertinent provisions of Ordinance No. SP-2459, S-2015, otherwise known as the Revised Quezon City Market Code.
