A RESOLUTION GRANTING A SPECIAL PERMIT TO "DAVID-BASBAS GAMING ENTERPRISE CORPORATION" TO OPERATE AN ELECTRONIC BINGO BOUTIQUE AT WILCON CITY CENTER LOCATED AT NO. 121 VISAYAS AVENUE, BARANGAY BAHAY TORO, QUEZON CITY, IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO. SP-2285, S-2014.

WHEREAS, "David-Basbas Gaming Enterprise Corporation" is applying for a Special Permit for the operation of an Electronic Bingo Boutique at Wilcon City Center located at No. 121 Visayas Avenue, Barangay Bahay Toro, Quezon City;

WHEREAS, the Sangguniang Barangay of Barangay Bahay Toro and the residents therein interpose no objection to the said Electronic Bingo Boutique;

WHEREAS, the Electronic Bingo Boutique will not adversely affect public health, safety and welfare and is in keeping with the general pattern of development in the area;

WHEREAS, under the provisions of Quezon City Ordinance No. SP-2285, S-2014, a Special Permit from the Quezon City Council is required for the operation of an Electronic Bingo business.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant a Special Permit to "David-Basbas Gaming Enterprise Corporation" for the operation of an Electronic Bingo Boutique at Wilcon City Center located at No. 121 Visayas Avenue, Barangay Bahay Toro, Quezon City, in accordance with provisions of Quezon City Ordinance No. SP-2285, S-2014.

RESOLVED, FURTHER, that "David-Basbas Gaming Enterprise Corporation" shall remit annually to the City Treasurer a franchise fee of three percent (3%) of its annual gross sales.

RESOLVED, FINALLY, that the Special Permit herein granted shall be effective for a period of two (2) years only subject to renewal by the Quezon City Council.
