RESOLUTION NO. SP- 7029 S-2017

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO LARRY'S EXPRESS, INC. FOR THE CONSTRUCTION OF EIGHT (8)-STOREY COMMERCIAL BUILDING WITH BASEMENT AND ROOFDECK LOCATED AT LOT 1 BLOCK W-8 WEST AVENUE CORNER DEL MONTE AVENUE, BARANGAY PALTOK, QUEZON CITY, ALLOWING DEVIATION FROM PARKING REQUIREMENT AS PROVIDED UNDER ORDINANCE NO. SP-918, S-2000, AS AMENDED, OTHERWISE KNOWN AS THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE.

WHEREAS, Larry's Express, Inc. is applying for a Certificate of Exception for the construction of Eight (8)-Storey Commercial Building with basement and roofdeck located at Lot 1 Block W-8 West Avenue corner Del Monte Avenue, Barangay Paltok, Quezon City, to deviate from the parking requirement mandated by law;

WHEREAS, the Sangguniang Barangay of Barangay Paltok and the residents therein interposed no objection to the said project;

WHEREAS, the subject commercial building has a limited parking space which is unique and different from other properties in the locality. Nonetheless, it will not adversely affect public health, safety

WHEREAS, the applicant has complied with the necessary requirements prescribed by Law, Ordinance or Administrative Issuances.

WHEREAS, in accordance with the provisions of the Quezon City Comprehensive Zoning Ordinance and its Implementing Rules and Regulations, an exception is required for the said commercial building.

NOW, THEREFORE;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Certificate of Exception to Larry's Express, Inc. for the construction of Eight (8)-Storey Commercial Building with basement and roofdeck located at Lot 1 Block W-8 West Avenue corner Del Monte Avenue, Barangay Paltok, Quezon City, allowing deviation from parking requirement as provided under Ordinance No. SP-918, S-2000, as amended, otherwise known as the Quezon City Comprehensive Zoning Ordinance.
